Our role

Residuary

We ask the supporter if they would like to leave a percentage of their estate to your charity.

Your charity's name, address and charity number are pre-loaded.

Your Residuary Estate

 This is usually the most important part of a will

Your residuary estate covers all money or possessions left over when specific gifts have been distributed and all other expenses (fees, debts, etc) have been settled.

You will have the chance to give specific gifts on the next page.

Residuary beneficiaries are often your spouse or children, and can also receive specific gifts.

By selecting "what happens if this person dies before me", you can say what happens to this part of your estate if the intended recipient is unable to inherit, for example if they die before, or at the same time as you.
